Frequently Asked Questions

Who can place a Gala sponsorship ad?

Sponsors at all levels can place a full-page ad in the printed Gala Program Journal to be distributed at the gala to each guest. In addition, all sponsors can provide an electronic ad that will be displayed on the screens during the gala.

Who designs the sponsorship ad?

When is the deadline?

The deadline is Wednesday, March 12, 2025 for the print Gala Journal ad.

The deadline is Friday, April 4, 2025 for the ballroom screen electronic ad.

How do you design an ad?

All ads must be created in an industry-standard design program. Please DO NOT create ads in Microsoft Word, Publisher, WordPerfect, Canva, or any other word processing program.


What do typical sponsorship ads look like?

A typical ad will include a congratulatory message for the Gala honorees and express support for NIAF. Also acceptable are personal, family and corporate ads. Many company ads incorporate a logo, an image, a message, and basic corporate information (brief promotional text and a company website address).

What are the specs required for the electronic sponsorship ad?

- · Must be full color
- Must be high-resolution (300 dpi)
- Measure 10" wide by 7.5" high
- Landscape orientation
- · Send as a JPEG file



Frequently Asked Questions

What are the specs required for the print sponsorship ad?

- Must be full color
- Must be high resolution (300 dpi)
- Measure 8.375" wide x 10.625" high
- Must include trim marks and bleeds .125" all 4 sides
- Portrait orientation
- · Send as a press-ready PDF file

Gala Journal PRINT Ad Specs



Ad Size - the actual page size of the Gala Journal.

Bleed Area - when color or images run off the edge of the page. The extra .125" on all sides will make sure color and images successfully runs off the page when trimming the Journal.

Live Area - to make sure any logos, type, etc that is kept in the safe area without risk of being trimmed off in the printing process.

Are Gala sponsorships tax deductible?

Most sponsorships are partially tax deductible (see chart below). NIAF's Federal ID# is 52-1071723.
